Policy

- Updated principles to state hand hygiene aligns with AHS core values and foundational strategies.
- Added language to emphasize the importance of frequent hand hygiene. (1.1)
- Provided clarity that wall-mounted dispensers should be clearly labelled. (3.3)
- Added reference resource for managers <u>Hand Health Frequently Asked Questions</u>. (4.3)
- Expansion and further clarification on appropriate nail care, including artificial nails (5.3).
- Update on examples of wrist accessories. (5.5)
- Reinforced messaging of managers' responsibility for compliance and enforcement. (6.1)

Procedure

- Updated to explicitly state that ABHR is not to be used after using the washroom. (2.1c)
- Expansion and further clarification that plain soap is needed to wash hands. (2.3)
- Clarity that tap water is **OK** to use during boil water advisory followed up by ABHR. (2.4)
- Procedure for soap and water now Section 3 formally Section 4
- Procedure for ABHR now Section 4
- Update and clarification on how to apply ABHR and what areas need to have the application of ABHR. (4.4)
- Update language from warm water to comfortable temperature and clarity on where to apply soap (update to include wrist surfaces). (3.2)
- Increased handwashing time: 15-30 seconds. (3.3)
- Preferred used of disposable paper towel. (3.5)
- Update to include wrist surfaces. (4.4)
- Added for clarification "until hands are completely dry" or 20-30 seconds (4.5)
- Reformat Section 6 to include National Fire Code Alberta Edition, where and clarity that wall-mounted ABHR dispensers shall be clearly labelled and installed.
- Updated Appendix for clarity.
