

## ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES ORDER TO VACATE

## To: TYLER WILLIAM WARD "the Owner"

And.

## CONDOMINIUM PLAN NO. 7921560 C/O CASTLEHEIGHTS CONDOMINIUM CORPORATION "the Owner"

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in Edmonton, Alberta and municipally described as: 13833 114 Street NW- Basement Suite [Plan 7921560 Unit 16]

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The bedroom window was too small for emergency egress, the unobstructed opening was measured and found to be 18 X 14 inches = 252 inches squared (1.75ft2) or (0.163m2). The required opening is 543 inches squared (0.35m2).
- b. There was no smoke alarm installed outside the bedroom.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The bedroom window was too small for emergency egress, the unobstructed opening was measured and found to be 18 X 14 inches = 252 inches squared (1.75ft2). The required opening is 543 inches squared which is in contravention of section III (3)(b)(ii) of the Minimum Housing and Health Standards which states that: shall provide unobstructed openings with areas not less than 0.35 m2 (3.8ft2), with no dimension less than 380 mm (15").
- b. There was no smoke alarm installed outside the bedroom which is in contravention of section IV(12) of the Minimum Housing and Health Standards which states that: Smoke alarms within dwellings shall be installed between each sleeping area and the remainder of the suite and, where hallways serve the sleeping areas; the smoke alarms shall be installed within the hallway.

c. Part of the ceiling was missing around the bathroom window and part of the flooring was missing under the refrigeration unit which is in contravention of section III(5)(a) of the Minimum Housing and Health Standards which states that: Rooms containing a flush toilet and/or a bathtub or shower shall have walls and floors that are smooth, non-absorbent to moisture and easy to clean. All walls shall form a watertight joint with each other, the floor, the ceiling and where applicable with the bathtub or shower and section III(5)(b) of the Minimum Housing and Health Standards which states that: Rooms and sections of rooms that are used for food preparation and cooking shall have walls and floors constructed of materials which do not provide harbourage to dirt, grease, vermin and bacteria and that are easily kept clean.

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

## NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the occupants vacate the above noted premises on or before 30 May 2024.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Install a bedroom window that has an unobstructed opening that is not less than 0.35 m2 (3.8ft2), with no dimension less than 380 mm (15").
  - b. Install a smoke alarm outside the bedroom in the hallway that serves the sleeping area.
  - c. Install additional drywall in the bathroom and install the remainder of the flooring the kitchen, both areas must have surfaces that can be easily cleaned.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
